

Disciplinary Action Submission Form


The Disciplinary Action Submission form is designed to record Disciplinary Actions on a Chronicle Level. These step by step instructions will show you how to record a Disciplinary action.

1. Go to www.owbn.net and click on “Staff Login”.



2. Type in your username and password, and then click on the “log in” button. The username is your first initial and last name.

Note: If you have forgotten your password, click on the “request new password” button. A password reset link will be sent to your email address.




3. If you are a CM, Storyteller, or both, you'll see links to the CM, Storyteller, or both dashboard.

Storytellers and CMs can Log Disciplinary Actions, so click one or the other.



4. In the Storyteller or CM Dashboard, click on “Log Disciplinary Action”.




5. Type in the player's name. If the name is already loaded on the owbn site, it will appear as part of the autocomplete. Click on the name and click on “Continue”.




- If the name doesn't pop up, it hasn't yet been added to the database, and a new participant entry will need to be created, which is outlined in step 7-8.


6. Be sure to verify the recipient's name. This page will list any other Disciplinary actions the recipient has received. If the name is correct, click on "continue". Proceed to step 9.



7. If you need to create a new participant entry, click on the check box next to "Create new participant entry in database", and then click "continue".



8. Type in the player's full name and, if available, email address. The email address is used for notifying the recipient of the disciplinary action. Click on "continue" when complete, and proceed to step 9.



9. On this next page, details about the Disciplinary Action will need to be provided. The first step is the chronicle that is issuing the Disciplinary action. This is a drop down list as a person can be a part of multiple storytelling staffs in the Org. Please make sure you pick the correct Chronicle that is giving out the Disciplinary Action.




